## EXECUTIVE SUMMARY

In FY 2022, Stockton University will focus on five initiatives. The first initiative, equitable funding, remains our highest priority. The additional funding provided in FY 2021 greatly benefits and recognizes Stockton's growth in Atlantic City. However, Stockton's funding still remains below the average for New Jersey senior public colleges and universities. Colleges that receive more state aid are better positioned to invest in faculty support, address capital and deferred maintenance needs, increase enrollment capacity, mitigate capital financing costs, and leverage institutional scholarships to recruit, retain, and graduate students. As the University continues to grow, equitable funding to support these efforts will be crucial to future success.

The opening of Stockton University Atlantic City in Fall 2018 has been a game changer for the University and the City. Stockton's second initiative involves expanding the Atlantic City campus. Demand for the Residential Complex, which houses more than 530 students, is at capacity, and more classes are being offered at the John F. Scarpa Academic Center. Atlantic City Phase II, a second Residence Hall, is currently targeted for completion in 2023. An addition to the Academic Center is also included in Stockton's 2020 Master Plan. As the population of residential students in Atlantic City grows, there will be a corresponding need for security, transportation, amenities, technology, and academic and recreational resources. Moreover, as an Anchor Institution, Stockton University plays a vital role in Atlantic City's economic revitalization. This fulfills the State's goals of economic diversification and development, and accessible and affordable education for underserved communities.

The third initiative includes a Coastal Resiliency Center in Atlantic City. As the impact of climate change becomes more evident at both the global and local levels, this Center will serve as a statewide research hub to address the impact of climate change on the Jersey shore. It will also build upon the work of Stockton's Coastal Research Center and provide new learning and research opportunities for faculty and students. This Center will reinforce Stockton's role in developing a 21<sup>st</sup> century workforce necessary for an innovative economy that includes a growing, sustainable energy sector.

The fourth initiative focuses on a new Multicultural Center. In 2020, the Board of Trustees publicly committed to diversity, equity, inclusion, and social justice at Stockton. The Center would provide a space on the Galloway campus to visibly demonstrate that dedication and address the needs of Stockton's increasingly diverse student body. This commitment is consistent with the State's growing diversity and enhances the University's ability to serve all New Jersey students now and in the future.

The fifth initiative supports advancements to Stockton's athletic programs. Funding would enhance resources for intercollegiate athletics, club sports, and intramural and recreation programs. A robust athletic program ensures equitable opportunities under Title IX, improves student health and wellness, and increases activities for students within the safe confines of campus. Plans for athletics and recreation growth are also detailed in the University's Master Plan.

Stockton is a growing, vibrant university committed to increasing student enrollment and enhancing the economic revitalization of the region. State support of these initiatives is critical to reaching our goals and those articulated in the New Jersey State Plan for Higher Education.

## FY 2022 STATE BUDGET OVERVIEW

The coronavirus pandemic has brought new challenges and unforeseen costs, as the faculty and staff have adapted to safely serve the nearly 10,000 students attending the University in Fall 2020. However, despite these challenges, Stockton University continues to make progress and use its financial resources to provide students with a quality education and meaningful student life experiences.

In Fall 2021, Stockton University will celebrate its **50<sup>th</sup> Anniversary** of teaching. The campus has changed tremendously over the past 50 years, while still holding true to its mission of serving students and the community. The first class of 1,000 students met in the former Mayflower Hotel in Atlantic City, while the first buildings on the sprawling 1,600-acre Galloway campus were completed.

Today, students are once again living and learning in the city at **Stockton Atlantic City**, which opened in Fall 2018, and they are bringing energy and diversity to the city. Stockton's return to Atlantic City has been so successful that the University broke ground in October 2020 for a new Residence Hall targeted to open in 2023.

While Stockton University's enrollment has increased tenfold since its opening, state aid has not kept pace. As the only four-year institution in the region, Stockton continues to focus on providing an affordable and quality, college education to students in some of the most socioeconomically distressed areas of the state. With South Jersey counties facing double-digit unemployment, Stockton students deserve and need more help.

Governor Murphy's funding initiatives have helped Stockton maintain affordable, yet competitive tuition and fees among the state colleges. However, as it pertains to direct State appropriation per full-time equivalent student, the University is still the least-funded of the state public colleges and universities. The University needs **equitable support** from the State to provide the services that will help students to be successful.



## STOCKTON UNIVERSITY ATLANTIC CITY



As the gaming, hospitality, and tourism industry struggles through the coronavirus pandemic, Stockton Atlantic City's role as a state-designated **Anchor Institution** in the city has become even more crucial to revitalizing and diversifying the economy.

Demand has exceeded supply at the University's oceanfront student housing, which can accommodate more than 530 students. In October 2020, the University **broke ground for a second Residence Hall** that will house more than 400 students. State support has allowed Stockton to proceed with the AC Phase II project. With a targeted completion in 2023, the vision for expanding the Atlantic City campus is becoming a reality.

The Fannie Lou Hamer Event Room in the John F. Scarpa Academic Center has hosted events for the local community and sponsored events of national interest. These events have included the **2<sup>nd</sup> District Congressional Debate** in 2020, and an international conference on faith-based terrorism in 2019 that brought great recognition to Atlantic City.

Students enrolled in the Hospitality, Tourism and Event Management Program participate in **hands-on learning experiences and internships** in area casino hotels. Environmental science professors take advantage of the surroundings by holding lessons on the beach as an extension of in-class learning.

In Fall 2020, Atlantic Shores Offshore Wind, LLC signed a lease for one of the commercial sites at the Residential Complex on the Boardwalk. There, they will locate an **Educational and Community Outreach Center** for the community and provide internship opportunities for Stockton students.

The excitement of Stockton Atlantic City extends beyond the campus. Flags for the new **University District** in the Chelsea neighborhood present a new identity for the area. Stockton students helped to renovate the nearby O'Donnell Park by brightening up the entrance to both the campus and the city.



### A MODEL FOR SUSTAINABILITY AND RESILIENCY



Much of what we know about beach erosion in New Jersey can be attributed to the decades of research by Dr. Stewart Farrell and the staff of **Stockton University's Coastal Research Center**. Stockton is now in the forefront of developing a Coastal Resiliency Center that will provide crucial research opportunities for faculty, staff, and students to develop and implement the State's plan.

On Stockton's main campus in Galloway, the **Sustainability Lab** provides a forum to teach students how to solve real-life energy issues. Students study sustainable agriculture at the **Stockton Farm**, and sell their produce at local farm markets. A grant-funded project is studying the potential for **maple syrup production** in New Jersey. Through Stockton's Diamondback terrapin project, more than **300 rescued and hatched terrapins** were released in Atlantic and Cape May counties.

Stockton's **partnerships with Ørsted and the Atlantic Shores Offshore Wind, LLC** will benefit students, faculty, and staff as the companies develop state-approved wind farms. Students also learned how Ørsted uses sonar to track undersea activity.

At the **Stockton Marine Field Station**, faculty and students are also helping to restore the oyster industry in Barnegat Bay through their research with the **Barnegat Bay Partnership** on how oysters can restore the bay's damaged ecosystem. Another project on seagrass helps to support marine life and stabilize the coastline.

The Marine Field Station has also **brought history to life** on the waters. Faculty and students are researching and exploring a shipwreck off the Atlantic City coast, and the sinking of the Bead wreck at the Battle of Chestnut Neck which took place during the American Revolutionary War.





## EXPERIENTIAL LEARNING



The coronavirus pandemic stalled many student internships, but faculty and staff still found ways in 2020 to engage students both in person and online.

For the fourth consecutive year, students submitted an experiment that was accepted by the **International Space Station**. Student Sophia Bradach worked with Dr. Peter Straub, Dean of the School of Natural Sciences and Mathematics, to see if snow peas could self-fertilize in microgravity and create a viable food source.

Kathleen Ngo, a senior chemistry and biochemistry major, discovered a bright idea for a new type of light source after using an unexpected chemical during her research with Dr. Wooseok Ki, Assistant Professor of Chemistry. Their **research was published** in the journal, "Chemical Communications."

A record 27 students spent a semester in the **Washington**, **D.C. Internship Program** in the spring, and are completing both virtual and in-person internships in the fall. Many learned valuable crisis management skills doing social media internships with government agencies over the summer.

With the casinos closed, hospitality students operated a simulated business online. These simulations required them to manage all aspects of a business, from pricing and ordering to marketing and hiring.

While many programs are currently on hold, Stockton's **Office of Global Engagement** continues to help students plan for their dream of studying abroad. In 2019–2020, art students and student teachers traveled to Taiwan as part of the Stockton's Education Abroad Program.

Student veterans can take a unique class that relates the work of the Greek poet, Homer, to their own war experiences. This class includes a trip to Greece during spring break, where students relate *The Odyssey* to their own lives.



## EARLY EXPOSURE TO COLLEGE



Stockton University is committed to meeting Governor Murphy's goal of providing students with an affordable and accessible education. Since 2019, Stockton has served over 180 middle and high school students (grades 7-12) from the Atlantic City School District and the Pleasantville Public Schools in the **GOALS/GEAR UP** (Goal Oriented Advocates Leaders and Scholars) program. During the pandemic, the program remains active online, offering academic, leadership, and personal support until in-person activities can be resumed.

More than 1,000 students in 32 area high schools are enrolled in Stockton's **Dual Credit Program**. Through Stockton, secondary students have the opportunity to earn college credits while completing high school course requirements simultaneously. Students can enroll in classes in the following 12 areas of study: Communication Studies, Sociology and Anthropology, Africana Studies, Survey of Mathematics, Service Learning and Civic Engagement, Health Sciences,



Holocaust and Genocide Studies, World Language Studies, Math and Science Studies, Media Production, Criminal Justice, and Tomorrow's Teachers/Pathways to Learning (Education). Those credits will save high school participants thousands of dollars in tuition costs at Stockton and will shorten the time it takes to graduate.

Stockton's **Transfer Pathways Program** currently partners with nine community colleges to offer dual admission. This provides students with a smooth transition from their associate to bachelor's degree.





## SUPPORTIVE FACULTY AND STAFF



Stockton University's **Student Success Scholars Program** recognizes the many challenges faced by college students today and provides personnel and programs for additional support. Peer mentors and counselors develop relationships that students need to succeed and graduate on time.

The **First Ospreys** retention initiative reaches out to students who are the first in their families to attend college. This program's mission is to foster a support system and sense of community for first-generation students to ensure a successful college experience.

The expanded Educational Opportunity Fund (EOF) Program includes **a cohort at Stockton Atlantic City**. Students attend summer workshops that integrate them into the community. Every student at Stockton has a preceptor to advise and guide them through their higher education journey.

Stockton **TALONS (Transition Activity Leaders of New Students)** and student **Ambassadors** reach out online and in person to meet with incoming freshmen and help them feel at home and acclimate to college.

More than 100 incoming freshmen participated in the summer 2020 **Go Global Program**, a unique course designed to immerse students in global issues, as well as introduce them to college material, research and writing methods, and other freshmen.

In 2020, the Board of Trustees publicly committed to diversity, equity, inclusion, and social justice at Stockton. The new **Multicultural Center** would provide a space on the Galloway campus to visibly demonstrate that dedication and address the needs of Stockton's increasingly diverse student body through supportive services, faculty, and staff.



## SAFE AND SUPPORTIVE CAMPUSES



Stockton is a community of many interests. The University hosts more than 160 clubs and organizations. The campus **Culture of Respect** initiative reinforces the University's commitment to civility, community, and safety by offering dozens of special programs and projects throughout the year. While many programs and events are now offered virtually, counselors and staff are just a phone call or Zoom meeting away to answer questions and provide support services.

In Fall 2020, the **"Soar Safely, Ospreys!"** initiative has helped to reinforce on-campus health and safety guidelines and protocols, including the **"Mask Up!, Back Up!, Wash Up!"** campaign. Over 600 hand-sanitizing stations were placed throughout the campus to help provide a safe environment for students, faculty, and staff.

The **Stockton Student Relief Fund** has helped students pay for books and car repairs. In addition, the campus food pantry and food assistance program have provided necessities and kept students nourished.

Stockton Athletics offers a broad range of options that support the health and wellness of Stockton students, faculty, and staff. The University offers **19 intercollegiate men's and women's sports** and **18 club and intramural sports**, including golf, volleyball, table tennis, fencing, and ice hockey. Public support helped launch a new **expanded rowing** program, while Stockton's **esports** team has attracted a new breed of competitors. Yoga and meditation classes are currently offered online to students, as well as alumni.

During the pandemic, Athletics found creative ways to keep students active and engaged. Horseshoe and corn hole tournaments, as well as other outdoor, socially-distanced games were made available.

In October 2019, Stockton expanded the **Office of Military and Veteran Services**. The lounge and larger office provide easier access to services for student veterans. **The Women's, Gender and Sexuality Center** continues to offer privacy and a supportive environment for students addressing sensitive and personal topics.



## STOCKTON IN SOUTH JERSEY



Stockton University's reach goes well beyond its Galloway and Atlantic City campuses. Sites in **Manahawkin**, **Hammonton**, **and Woodbine** extend Stockton's offerings throughout South Jersey, while providing academic and public programs that benefit the entire community.

Stockton University at **Manahawkin** is home to Stockton's Accelerated BSN Nursing Program. This instructional site offers a six-bed Foundations of Nursing Lab with simulated patients and exam rooms that provide students with realistic learning experiences.

Kramer Hall in **Hammonton** hosts the Master of Data Science and Strategic Analytics and the Master in Counseling Programs. This site also houses a gallery for the Noyes Museum of Art at Stockton.

Stockton's **Woodbine** site includes the Sam Azeez Museum of Woodbine Heritage, which preserves the history of the Russian Jews who settled the area in the late 19<sup>th</sup> century. This instructional site is a designated teaching center for the New Jersey Commission on Holocaust Education.



## CORONAVIRUS RESPONSE



The challenges of the **coronavirus pandemic** have affected all aspects of university life for every student, faculty, and staff member. Stockton saw firsthand the impact of COVID-19 from courses that switched online in a matter of days, to the ubiquitous masks that are required, to the drastic change in campus life.

Stockton has met those challenges through creative thinking and always remembering our motto of "Students First." Computers were loaned to students that did not have their own personal device. Campus buildings remained open, albeit with more limited access, for students who needed Wi-Fi. Housing remained open for international students that were unable to return home and others facing housing insecurity. All university services were made available by phone, e-mail, and Zoom. Senior projects were performed and posted online.

As Stockton prepared to open for the fall, truckloads of plexiglass, hand-sanitizing stations, and wipes were ordered, while signage was printed and posted.



For **prospective students**, Stockton is now completely test optional, with no requirements to submit SAT or ACT scores as part of the application process. Scholarship criteria also has been adapted to recognize how students are learning and living now. Open Houses are now provided in a virtual format, although families can still come for one-on-one personal tours.

While this is a challenging time for higher education, Stockton University remains committed to its students, faculty, staff, and the communities that we serve. State support is critical to continue to respond effectively to the coronavirus pandemic.





## EQUITABLE FUNDING



Stockton supports Governor Murphy's student-centered vision for New Jersey Higher Education. The University is grateful for the additional state aid that was designated in FY 2021.

However, due to decades of chronic underfunding, Stockton remains the **least-funded of the senior public universities** as it pertains to direct State appropriation per full-time equivalent student. Stockton has done its share to remain affordable, as its tuition and fees are in the mid-range among the state public colleges and universities.

Stockton University is the only four-year college in the southeastern part of New Jersey. While Stockton remains steadfast in its mission to serve all students in New Jersey, we have a special responsibility to those living in our local South Jersey communities, which are among the most socioeconomically challenged in the state.

#### FY 2022 PREFACE

Almost 50 years after opening in 1971, Stockton University remains the only comprehensive college or university in southeastern New Jersey. As such, Stockton has expanded to serve the needs of its area residents.

Stockton University's enrollment continues to grow, with nearly 10,000 students taking classes in Fall 2020. The University remains steadfast in its goal of enrolling 10,000 students.

Stockton's main campus in Galloway is located on over 1,600 acres in the Pinelands National Reserve. The Academic Quad opened in 2018 and includes both the Unified Science Center and a Health Sciences Center. The campus features a closed-loop geothermal heating/cooling system, and solar panel carports in several parking lots.

In April 2016, the State of New Jersey designated Stockton University as an Anchor Institution in Atlantic City. In Fall 2018, the University opened Stockton University Atlantic City, which has helped to revitalize the City. This beachfront campus includes residential housing and the 56,000-square-foot John F. Scarpa Academic Center that serves both students and the community. The \$178.3 million campus also offers a parking garage and retail sites. In October 2020, the University broke ground for a second Residence Hall that will house more than 400 students. This AC Phase II project is expected to be completed in 2023.

In Atlantic City, the University owns the Stockton-Rothenberg Building which houses the Lloyd D. Levenson Institute of Gaming, Hospitality and Tourism, the Office of Continuing Studies, and the Small Business Development Center for Atlantic, Cape May, and Cumberland Counties. The Carnegie Center, a 17,335-square-foot historical building, is available for the University's use. Stockton also operates the Noyes Arts Garage in Atlantic City.

Additional instructional sites at Kramer Hall in Hammonton, Atlantic County, and the Sam Azeez Museum of Woodbine Heritage and Anne Azeez Hall in Woodbine, Cape May County are operated by Stockton University. The site in Manahawkin expanded in January 2018 to meet the growing demand in Ocean County. The Marine Science Laboratory along Nacote Creek in Port Republic, provides students with additional opportunities.

The Parkway Building, located on Jimmie Leeds Road in Galloway, houses the Southern Regional Institute and Educational Technology Training Center (SRI-ETTC). The SRI-ETTC provides professional development training to one-fourth of all school districts in New Jersey.

The University offers apartment- and dormitory-style living arrangements to its students. Housing on the Galloway campus accommodates over 2,900 students, while the Atlantic City campus, located on the Boardwalk, accommodates more than 530 students.

Stockton University partners with the National Aviation Research and Technology Park (NARTP) in Egg Harbor Township. The \$17.2 million, 66,000-square-foot building is the first of seven planned for the 58-acre park located adjacent to the FAA William J. Hughes Technical Center and Atlantic City International Airport.

#### FY 2022 Budget Request & Initiatives

#### FY 2022 BUDGET REQUEST SUMMARY

Full funding of Stockton University's FY 2022 Budget Request will advance the University on its ambitious path to provide a high-quality, affordable education to all citizens of New Jersey. In Fall 2018, Stockton made higher education history in New Jersey with the opening of a \$178.3 million residential campus in Atlantic City. In October 2020, the University broke ground for a second residence hall that will house more than 400 students. In addition, the University continues to challenge itself to meet its established goals and implemented programs developed during the Middle States re-accreditation process, including:

- Enhancement of undergraduate and graduate education by: launching new programs; developing comprehensive learning assessments; enabling effective pedagogy; ensuring that advances in technology and alternate modes of instruction enhance quality and excellence, and strengthening the freshman year experience.
- Meeting the capacity challenge by: managing enrollment growth while increasing retention, and implementing the Facilities Master Plan for the coming decade.
- Maintaining affordability by: meeting enrollment and fiscal benchmarks; matching funding and staffing to institutional priorities; increasing university supported aid to students, including support for internships, and building a strong institutional advancement function so that major fundraising campaigns complement state support, thus controlling costs passed on to students.

Stockton University's anticipated FY 2022 Direct State Appropriation is \$24,366,000<sup>1</sup>. Stockton requests total funding of \$41,028,123. This encompasses the priorities totaling \$16,662,123 and 30 additional State-funded lines.

The University's priorities are as follows and are presented in detail per the required format at the end of this document.

- 1. Equitable Funding: \$7,656,123 (Page 31)
- 2. Atlantic City Campus: \$4,500,000 (Page 32)
- 3. Atlantic City Coastal Resiliency Center: \$1,843,000 (Page 33)

- 5. Advancing the Athletic Programs: \$1,563,000 (Page 36)

#### Summary:

Despite fiscal constraints and the challenges presented by COVID-19, Stockton University continues to provide an atmosphere of excellence for the college-bound students of New Jersey. If base budget erosion continues, quality will suffer. Accordingly, Stockton's FY 2022 State Budget Request seeks to strengthen the entire educational fabric of the University, including Galloway, Atlantic City, and the off-campus instructional sites, so that all segments of the campus community move forward together in implementing the University's Mission, Vision, Values, and Strategic Plan.

1 The FY 2022 estimated appropriation is based upon Stockton University's direct State appropriation as listed in the FY 2021 State of New Jersey Appropriations Handbook. This estimate includes the additional \$2M resulting from P.L.2020, c43 that was part of the FY 2020 Appropriations Act Bill for the three-month extension of the fiscal year.

The \$24,366,000 includes \$2M resulting from P.L.2020, c43 that was part of the FY 2020 Appropriations Act Bill for the threemonth extension to the fiscal year. The University currently receives the least amount of dollars per FTE students among New Jersey's senior public colleges and universities. To make Stockton's funding at par with the State average, an additional direct appropriation totaling \$7,656,123 is required.

The University is requesting \$4.5M in direct appropriation for the operations of the Atlantic City campus. The \$4.5M of requested funding will support the following: \$500K for adjuncts, \$300K for hourly workers, \$100K for student workers, 1.1M for shuttle service, \$300K for parking garage services, and \$2.2M for non-salary operational needs.

This initiative will provide funding for the academic, safety, operational, and administrative services of Stockton University's Atlantic City campus. The University opened the Atlantic City campus in Fall 2018, where Stockton welcomed more than 530 students to the residential complex on the boardwalk. The campus features the John F. Scarpa Academic Center, a 56,000-square-foot academic building inclusive of 14 classrooms, student common areas, an event room, and faculty and administrative offices. In addition, there are two instructional classrooms located in the adjacent residence building.

In October 2020, the University broke ground for a second Residence Hall that will house more than 400 students as part of the AC Phase II project. With a targeted completion in 2023, the vision for expanding the Atlantic City campus is becoming a reality.

#### Impact

Additional State funding will support the University's Atlantic City campus operations and will minimize increases to tuition and fees. The funding for the expansion of Stockton University Atlantic City will help support the University's mission to provide a high-quality, affordable, and accessible education to a diverse population, while serving the needs of area residents. This will enable more college students to remain in New Jersey and succeed in today's global society.

#### **Out-year Considerations**

The additional funding request of \$4.5M should be considered a permanent addition to the University's direct appropriation to allow for the continued operation of the Atlantic City campus. This funding will help the University and the State to achieve goals of increasing the capacity of New Jersey public institutions and serve the growing number of students requiring public higher education.

Stockton University is requesting \$1,843,000 in direct appropriation and an additional 15 State-funded positions to support the operations of the Coastal Resiliency Center in Atlantic City, New Jersey. This Center will focus on research and teaching. Stockton's approved Coastal Zone Management graduate degree program will be based in Atlantic City and will open in Fall 2021. The Atlantic City Coastal Resiliency Center will target the many issues facing New Jersey's coastline, including: flooding, development, global climate change, resiliency, offshore energy development, stewardship of New Jersey's natural resources, and sustainable economic development.

The requested funding will support the following 15 positions: 1 - Director (\$185K), 7 - Faculty (\$738K), 5 - Professional Staff (\$325K), 2 - Clerical Staff (\$110K), as well as \$21K for coordinator compensation and \$192K for graduate research assistants in Atlantic City. Programmatic (non-salary) funding of \$272K will be designated for Science, Technology, Engineering, and Mathematics (STEM)-based undergraduate and graduate programs for the Atlantic City campus. These programs will foster a growth in enrollment in the City, as well as provide additional opportunities for the in-state education of residents.

#### Impact

Stockton University's Coastal Resiliency Center in Atlantic City will operate closely with other state agencies, including the New Jersey Department of Environmental Protection (NJDEP), other New Jersey colleges and universities, and the developing offshore energy industry. A "Blue Economy" incubator is also envisioned to encourage local, innovative, and entrepreneurial economic solutions and technologies to promote sustainable use of the coastal oceans. These will help to address living and working conditions in the coastal zone. This initiative will support the diversification of Atlantic City's economy by attracting research and development opportunities and partners to the region.

#### **Out-year Considerations**

The additional funding request of \$1,843,000 should be considered a permanent addition to the University's direct appropriation.

Stockton University is requesting \$1.1M in direct appropriation and an additional seven (7) State-funded positions to support the University's goal of creating a Stockton University Multicultural Center. The Center would directly support New Jersey's State Plan for Higher Education's Student Bill of Rights, Goal #9: Safe, Supportive, and Inclusive Campuses. It is both the State's and Stockton's goal that every student should feel safe and supported in his/her learning environment. To achieve this, the University must ensure that it provides a safe and inclusive campus and learning environment where all feel welcomed.

The Stockton University Multicultural Center will support the New Jersey State Plan for Higher Education by: 1) Cultivating counter-spaces to support the engagement, belonging, and development of African-American, Latinx, Asian, and Native American (ALANA) students; 2) Educating all students to advocate for social and racial justice on campus and in their communities.

The Multicultural Center will offer programs and services to promote awareness, safety, and respect for and amongst all members of the Stockton Community. This initiative coincides with the Student Affairs' Administrators in Higher Education (NASPA) – A Culture of Respect model.

The requested funding will support the following seven (7) positions: 1 – Director (\$95K), 3 – Assistant Directors/Counseling Multi-Cultural Specialists (\$222K), 1 – Assistant Director/Program Coordinator (\$64K), 2 – Program Assistants (\$100K), as well as both graduate and student assistants/workers (\$70K). Non-salary funding of \$549K will support program resources, guest speakers, professional development opportunities, retention efforts, program incentives, and other operational costs needed to launch this initiative.

#### Impact

The Stockton University Multicultural Center will benefit the entire campus community and community-at-large. This Center will provide and facilitate year-round educational programming and incentives, counseling services, and professional development/training in an effort to foster an ethos of community-wide respect and safety, while advocating for social and racial justice.

Budgeting challenges are a significant obstacle to implementation. Since current non-salary budgets are limited, allocating funds from existing programs will create a negative and adverse effect on those programs.

A dedicated space for the Stockton University Multicultural Center is required.

#### **Out-year Considerations**

The additional funding request of \$1.1M should be considered a permanent addition to the University's direct appropriation. The Stockton University Multicultural Center would be best served with support of long-term, dedicated funding from the State.

Stockton University is requesting \$1,563,000 in direct appropriation and an additional eight (8) State-funded positions to support Stockton's Advancing Athletic Programs. This initiative is a direct result of the recommendations in the Athletic Facilities Task Force's 2020 Report. The funding and new positions will also improve resources for the existing programs, which will facilitate expanded offerings for the overall advancement of Stockton Athletics. This initiative focuses on achieving the following three goals identified in the Athletic Facilities Task Force Report:

1) Become a premier NCAA Division III Athletics program.

2) Improve fitness, wellness, and recreation opportunities for the entire campus community.

3) Enhance and expand academic opportunities.

Achieving these areas of Athletics will foster the health and wellness of the entire campus community. It will also promote higher student retention through increased participation and engagement in Athletics programming.

The requested funding will support the following 8 positions: 1 – Track & Field Coach (\$102K), 1 – Assistant Sports Information Director (\$73.5K), 1 – Facilities Manager (\$93K), 1 – Strength & Conditioning Coach (\$73.5K), 1 – Intramurals Assistant (\$73.5K), 1 – Aquatic Center Manager (\$102K), 1 – Fitness Center Manager (\$93K), 1 – Clerical Staff (\$54K), as well as \$123K for part-time salaries, and \$231K for student workers. Operations and programmatic (non-salary) funding of \$544,500 will be designated for the intercollegiate, club sports, and intramurals & recreation programs.

#### Impact

With the State's support of this initiative, Stockton Athletics will be better positioned to more positively impact the health and wellness of the campus community and improve student retention, which correlates with greater engagement in athletic programs. That heightened engagement often equates to a more satisfactory student experience during the college years. This in turn, translates to an increase in student involvement and reciprocated support of the institution after graduation. Last, the funding will also promote teaching, learning, research, and programming synergies with academic programs, such as the Health Sciences and the Campus Life Wellness Center.

#### Out-year Considerations

The additional funding request of \$1,563,000 should be considered a permanent addition to the University's direct appropriation.
