## **Business Meeting**

Approval of minutes: approved.

<u>Update by Provost</u>: A committee has been formed to consider the reopening of the University in the Fall of 2020. The goal is to have a plan by mid-July.

<u>Dismissal by Provost –  $2^{nd}$  Reading</u>: Review of the proposed revisions presented by John Smith. Concern was expressed about potential conflict between changes and requirements for some programs' accreditation. Concern expressed about this moving power away from faculty and to administrators. Smith suggests we postpone while changes are made so language does not conflict with accreditation requirements.

Motion to postpone to next meeting in order the make changes. Seconded. Postposed until September meeting.

<u>Master of Public Health –  $2^{nd}$  Reading</u>: Expressions of support for the program by a number of members.

Vote on proposal: proposal passes 26-3

<u>Library</u>: Question about new policy for streaming videos in class.

Research and Professional Development: Question about possibility of changing policy related to timing for funding considering most faculty do the bulk of their research over the summer. Questions about loss of funding for projects following budget cuts related to coronavirus. Suggestion for change in policy so faculty can apply for two-year terms for funding rather than being limited to one year. Questions about whether funds that have been frozen will be renewed or whether faculty will need to reapply.

<u>Task Force on Faculty Visa: Yulong "Helen" Gu</u>: The Task Force met several times, has met with administration, and been in communication with other New Jersey institutions. The administration is still in the process of amending the policy. We are asking for an extension of the Task Force.

## Proposals for next year

- 2. Concern about lack of centralized guidance related to what faculty should be doing related to internships in the context of the coronavirus.
- 3. Suggestion that we consider the increasingly burdensome changes related to hiring new faculty.
