- 1. Proposals- Programs
 - 1.1. The <u>Bachelor's of Fine Arts in Creative Writing</u> first reading occurred on 9/26/19 and the proposal was approved 10/24/19 (8-yes, 0-no) to move forward to the Faculty Senate with minor revisions regarding quantitative data analyses. This BFA will provide a new studio arts degree that aims to prepare students for careers in professional writing across a wide range of genres.
 - 1.2. A 'second' reading of a revamped <u>Master's in Public Health with Concentrations</u> <u>in Community Nutrition and Substance Abuse</u> (original proposal was discussed 9/27/18) was discussed at the 2/27/20 and 3/27/20 meetings. While the committee was enthusiastic about the proposal, multiple issues were discussed ranging from resources (faculty, internship, and library), course sequencing, and the potential for collaboration with SOBL. No vote was held at that time; proposal moved forward to Faculty Senate.
- 2. Proposals- Concentrations
 - 2.1. The first reading for the <u>Music Education Concentration</u> occurred during the 9/26/19 meeting with the proposal unanimously approved at the 10/24/19 meeting (8-yes, 0-no). The only outstanding recommendation at that time was to include the Hanover report for the Faculty Senate. This concentration provides a career path for students that are interested in music education.
- 3. Proposals- Certificates
 - 3.1. The <u>Certificate in Forensic Accounting and Fraud Examination</u> was discussed during the 9/26/19 meeting. It was unclear to the committee whether this proposal should be developed as a track in the M.S. degree or a post-baccalaureate program. The committee also raised concerns regarding resources including the library and the potential need for new faculty. More specifics regarding the curriculum requirements and costs relative to certificates at community colleges were also topics. A revised certificate proposal did not return to committee.
- 4. Closure of Program Notifications- none
- 5. Informational Items
 - 5.1. A notification of name change of Hospitality and Tourism Management Studies to <u>Hospitality, Tourism, and Events Management Studies</u>. No action was taken.
 - 5.2. The library submitted a recommended change in language for new programs in relationship to library resources. The new language would require that proposals include complete descriptions of the necessary library resources and are accompanied by a letter from the Directory of Library Services that verifies the availability of these resources. No vote was taken, but the committee supported the adoption of this as policy.
- 6. Committee business
 - 6.1. The acting chair of the committee, Douglas Harvey, submitted his resignation to the committee on 3/27/20. Vice-chair Michael Law assumed the role of chair for the remainder of the academic year.
 - 6.2. There is still an issue with the lack of student representation on the committee. Students were not involved in any of the meetings.

- 6.3. The committee has discussed potential <u>procedural changes</u> that will aid in the review of all proposals
 - 6.3.1. We are requesting that all proposals that are sent back to AP&P for a second reading (or beyond) are accompanied by a cover letter detailing how suggestions or concerns raised by the AP&P committee were addressed.
 - 6.3.2. We are requesting that the AP&P committee provide a synopsis of our discussions regarding our most recent review of the proposal to the Faculty Senate.
