Project Title: MOU UTSM Chile & Stockton Initiation

Daniel Moscovici, PhD – Associate Prof - ENVL & SUST

#### Introduction/Background:

This projects seeks to develop a new international relationship through research, guest lectures and student opportunities. It will involve interdisciplinary work, multi-disciplinary global partnerships, and ultimately reinforces all of Stockton's 2020 Goals in the following order: global, sustainability, engagement, and learning. In addition, there are synergies for multiple departments at Stockton including SUST, ENVL, HTMS, ECON, MBA, PSM, MARS, GEOL, and the Caribbean/Latin American, Global Studies, and Spanish minors or concentrations.

Stockton is in the process of signing a Memorandum of Understanding (MOU) with Universidad Tecnica Santa Maria (UTSM) in Santiago Chile. The form has been signed by their rector and now needs signature from our new provost. I would like to seek funding for three activities to get the MOU started. First, I am requesting travel funding to present joint Stockton/UTSM research at an international conference (currently matching funds from NAMS Dean & sabbatical subvention). Second, funding can be used for the lead professor from UTSM to come to Stockton for guest lectures/collaboration on sustainability and economics in South America (currently matching funds from UTSM). Third, funding would be used to develop a field-study course for Stockton students to travel to Chile in 2018 (potential matching funds from India K's office).

Given the interdisciplinary nature of project, the collaborative/partnership of Stockton/UTSM through the MOU, and the multi-faceted ideas to enact it – the 2020 funding is the most appropriate source for this idea. It also further supports the seed money that Stockton has put in on the sustainable wine research over the years. Initially in 2012 Stockton supported two REU for undergrads, where students and I developed a survey and interviewed 75% of all wineries in the state to ascertain sustainable practices. This interdisciplinary work about New Jersey wine was presented at a reputable wine economics sustainable conference, with support of Provost Opportunity Funding and the Dean, in 2013, in S. Africa. One peer review paper has just been published, this fall 2016, in the International Journal of Economics and Business Research. Additionally, another paper will be submitted to the Interdisciplinary Environmental Review this winter 2017. This presentation and work drew attention internationally and led to collaboration between Dr. Valenzuela (Chile) and myself to replicate and compare sustainability practices between the Santiago region and New Jersey. We have collected about 75% of the needed data to run the numbers for presentation this coming summer. In addition, I taught a course on Wine Geography in 2013 as we applied for a big NSF wine teaching grant (unsuccessful). I plan to teach another G-Wine Geography course in summer of 2018 and hopefully this international/global content or partnership with Chile can be a major component. With the support from Stockton over the years it has led to publications, new courses, international presentations, and now the MOU. We are poised to take it to the next level with more publications, faculty exchanges, and student international opportunities.

#### Purpose/Goal:

The goal is to internationalize Stockton by initiating an MOU with UTSM in Chile. This will be achieved with three activities. First, presenting, then publishing, internationally collaborative research (wine

sustainability data from NJ & Santiago region of Chile) with colleague from partner University (UTSM - Chile), at an internationally recognized academic meeting (Association of Wine Economists – Padua, Italy). Second, bring in an expert speaker from our partner university overseas to present on economic and environmental issues in Chile (mining, fisheries, wine) at Stockton. This will benefit programs in SUST, ENVL, HTMS, ECON, MBA, PSM, MARS, GEOL, and the Caribbean/Latin American, Global Studies, and Spanish minors or concentrations. Third, to develop curriculum for students to travel to Chile, for a short-term study abroad program. This combined vision will have a strong impact on Stockton! Having an international guest speaker, collaborative/comparative and interdisciplinary presented and published research, and the opportunity for students to study in Chile starting fall semester 2018 will further our goal and reputation for excellence.

This request for funding leverages matching funds from within Stockton and UTSM.

#### **Activities:**

#### 3 Activities for MOU UTSM Chile:

- 1) I will present a paper on wine sustainability best management practices. The data for NJ is collected & mapped. The Chile data is currently being collected. I will be travelling this year, back to Chile, with sabbatical subvention funding, to finalize data collection. The conference is in June 2017, in Italy. The interest in wine and sustainability has increased at this conference significantly. Feedback from the conference will allow us to finalize the paper and submit for peer review publication. Furthermore, this interdisciplinary research can be used for course content to teach environmental studies, sustainability, economics, Caribbean & Latin American, and general education courses at Stockton
- 2) I will invite Dr. Valenzuela, from UTSM, to Stockton University to present at a variety of forums. He will present within his expertise, on developing sustainable business models for natural resources, specifically wine and other natural resources. Hopefully he can come during international week? And also present at the Environmental Seminar? Also it would be appropriate to have him present to the MBA & PSM students? I would be sure to partner with all entities at Stockton to maximize his lectures and exposure. Chile is at the forefront of natural resources management, climate change preparation, construction/rebuilding in earthquake zones, economic development, and South American politics. Also, during his visit we can discuss the opportunities to bring Chilean students to Stockton for a reverse field-study course something he is very interested in.
- 3) I will travel to Chile to visit three regions outside of Santiago to develop a study tour course on natural resources and development. This visit will allow me to negotiate with tour operators, find acceptable accommodation, and evaluate safety and transportation. Chile is a geographically long country and has a variety of ecosystems outside of the capital (high desert Atacama, glaciers Patagonia, coast/agricultural Casablanca/Valparaiso). This interdisciplinary course focusing on sustainability, economics, development, culture, art and architecture, agriculture and more would be good for students studying: environmental studies, sustainability, business, hospitality management, Caribbean and Latin American Studies, Global

Studies, Spanish Program and more. Students can take basic online courses to Learn Spanish before the course including DuoLingo or the Spanish program can advertise to students.

#### **Outcomes and Assessments:**

- 1) First, conference presentation at an international conference with subsequent publication of research in peer review journal (ideally Journal of Wine Economics or Society & Natural Resources). Also, it allows the opportunity to network and collaborate with other foreign scholars, apply for grants within the wine industry, and develop other MOUs with other universities around the world. Success will be measured by presentation of research and publication of research paper.
- 2) Allowing students, faculty and community to learn about interdisciplinary research from a scholar from South American and further globalize our campus. Success will be measured by number of students/faculty/staff attending the lectures and the publication of the visit in local papers, Stockton Times and maybe Presidents report. Ideally this will begin the exchange of lecturers between Stockton and UTSM more regularly.
- 3) Develop another short-term international opportunity for students to study abroad. The course will be interdisciplinary, and collaborative between Stockton and UTSM. Many students don't have the money or time to study abroad for a semester or more this short term opportunity can bolster Stockton's numbers of study abroad and globalize education for our generally regional students. Success measured by successful development of a field-study study abroad course.

#### **Summary of Budget Request:**

Total Requested is \$8,000 (3 parts) of \$14,000 for total project – includes Matching funds of \$6,000 from NAMS Dean, Stockton International Office, Universidad Tecnica Santa Maria, Sabbatical Subvention Funding.

- 1) \$1,750 for Research conference travel in June 2017. Total price of conference is \$5,500. Matching funds include: NAMS Dean \$1400, \$1350 from subvention funding, approximately \$1,000 from India K/International Office. Funds would be expended between 1/2017 and 7/2017.
- 2) \$1,750 for flight from Chile to US roundtrip for Chilean visiting scholar. Total cost for visit is \$4,000. Includes matching funds from UTSM of \$2,300. UTSM has already purchased 2 flights for me to lecture at UTSM in past one year. During my visits, Stockton covered the balance this demonstrates the collaborative relationship already in the works. For Dr. Valenzuela, UTSM will be able to cover the balance of their scholar coming to Stockton as reciprocation. Funding will be expended prior to 2/2018 in coordination of visiting lecturer schedule. The plan is for him to

- visit during late Fall 2017 semester or early Spring 2018 semester to coincide with their summer break & our winter
- 3) \$4,500 Approximate cost for flight, ground transportation, lodging, meals and guides in Chile for approximately 9 days to develop field study tour. Funding would be expended between 1/2017 and 6/2018.

Supplementary Information C – Projected Costs for Students Field Study Tour

This projected costs are theoretical. One of main goals of recon trip is to determine a full budget for students. Flights are expensive, but lodging, transportation & food is affordable in Santiago for travelers.

Total budget would ideally be \$2,000 or less to accommodate students. No Special visas are required

Flight: Approx \$1,100

Lodging: Approx \$500

Transportation: Approx \$300

Meals: \$200 – for inclusive meals – some meals will be on own
