Bittner Leads Team to ECAC Championship in First Season at Helm of Men's Basketball

Stockton University came from behind and defeated Penn State Behrend 74-72 to win the Eastern Collegiate Athletic Conference (ECAC) Championship in men's basketball for the first time. In his first season as Interim Head Coach, Scott Bittner led the Ospreys to win four games in five days to win the 12-team tourney and the team's first ECAC crown.

"The team showed great maturity and mental toughness," he continued. "This season was a great resemblance to life - no matter what challenges you face you have to keep getting back up and working toward a goal. That's what this team did, and that is the best part."

"I'm proud of the kids for dealing with some adversity of losing some key players to the team that we thought would be back," Bittner said. "Then, they had to deal with injuries and some setbacks on the court, but they kept showing up and working hard everyday.

The Office of the Provost announces the new <u>Dr. Vera King Farris Fellowship program</u>, which provides funding and an environment to teach, write and network for promising scholars committed to diversity in research and curriculum in public higher education.

Fellows will receive a stipend, office space equipped with computer technology, access to Stockton University facilities and mentorship by a Stockton faculty member. Fellows will teach two courses in their area of expertise each semester and are expected to participate in a significant project such as a creative/research project, curriculum development project, community engagement project, or another comparable activity. Fellows must make at least one presentation on campus that showcases their work and agree to complete an exit interview.

The Dr. Vera King Farris Fellowship program is named after the third president of Stockton University, who served the institution for two decades. State Appellate Court Upholds Stockton's 2016 Sale of Showboat to Bart Blatstein

The New Jersey Appellate Court on March 9 upheld a previous Superior Court ruling that enabled Stockton to sell the Showboat property in Atlantic City to developer Bart Blatstein for \$23 million in January 2016.

The appeals court ruled that Superior Court Judge Julio Mendez was correct in allowing Stockton to void its earlier contract with developer Glenn Straub after he did not make settlement on the property. Blatstein has since reopened it as a hotel.

President Harvey Kesselman said he was "extraordinarily pleased" with the ruling, which said Straub's appeal had no merit. He thanked attorney Stephen Hankin for ably representing both Stockton and Blatstein.

Adjunct Faculty Members Receive Funding for Research Projects

The following projects were approved for funding by the Stockton University Board of Trustees on Feb. 22:

Levi Fox, adjunct instructor in the School of General Studies, received \$750 for the A Time for Change Heritage Tour: A Walking Tour of African-American Historic Sites in Atlantic City project. The tour offered a place-based perspective on local history for students, staff, and members of the community. The two walking tours of 30 people each were in conjunction with Black History Month events in February at Stockton and help position the University as the logical place for future AC public history projects. Funding will be used for finalizing the tour route, research of each location, script writing and leading the tours.

Dona Jane Huggins, adjunct instructor in the School of Natural Sciences & Mathematics, received \$750 for Art and Music Analogies: Clarifying Content for Non-Science Majors. The project highlights analogies to abstract art and music used to teach scientific concepts in the life sciences to non-science majors. The funding supports travel to visit and observe a professor at Champlain College in Vermont who is using these analogies to teach general biology.

Gina Maguire, adjunct instructor in the School of Social & Behavioral Sciences, received \$750 for Knowledge is the Key: Elder Mistreatment and Abuse in Society. The funding supports enrollment in the American Society on Aging's Elder Mistreatment: Understanding Abuse and Neglect (part 1) certificate program during the spring or summer session. Goals for attending the program include expanding the Stockton's Aging & Health course and presenting for the University's Caregiving group and the Cape Atlantic Caregiver Coalition.

Peter Murphy, founder of Murphy Writing at Stockton, received \$750 for the Professional Development Through the Association of Writing Programs Annual Conference. Murphy was invited by a publisher to read self-authored poetry chapbooks, "I Thought I was Going to be Okay" and "The Last Pub on Earth" at the Association of Writing Programs annual conference, held in Washington D.C. from Feb. 9-12.

Stephen Nagiewicz, adjunct instructor in Marine Science, received \$750 for the Archaeological Mapping of Historic Sites project. Sites to be mapped include Mullica River shipwrecks, sonar and magnetometer mapping for shipwrecks that were part of a Revolutionary War battle in 1778, Chestnut Neck in Galloway, and Rancocas Underground Railroad and potential historic waterway sites dating back to late 1670s, Mount Holly.
