R&PD Mini Award -

- Support projects in research, planning, proposal writing, professional development and creative work. Funding for project support only.
- A pot of \$22,000 is available for an average award of \$1,700 for Spring Semester 2015.
- <u>Guidelines</u> are available on the Grants Office website and <u>applications</u> are due no later than 5:00pm, November 17, 2014.

R&PD Pilot Program: Scholarship of Engagement Award -

- Supports scholarship of engagement and involves Community Partners.
- A pot of \$50,000 is available for an average award of \$6,000 for FY16. Spring semester for organizing; project to unfold during summer. (Project may span 2 fiscal years)
- <u>Guidelines</u> are available on the Grants Office website and <u>applications</u> are due no later than 5:00pm, November 17, 2014.

Provost's R&PD in Academic Advising -

- Support for research on Stockton's academic advising programs with tangible outcomes expected.
- A pot of \$5,400 is available.
- <u>Guidelines</u> are available on the Grants Office website and <u>applications</u> are due no later than 5:00pm, December 1, 2014.

Provost Faculty Opportunities Fund -

- To support Stockton 2020 themes. Spring semester only event occurring during January April 2015.
- A pot of \$15,000 is available with an average award of up to \$2,000.
- <u>Guidelines</u> are available on the Grants Office website and <u>applications</u> are due no later than 5:00pm, December 1, 2014.

Grants Tip of the Month

The Principal Investigator/Project Director has primary responsibility for achieving the technical success of the project, while also complying with the financial and administrative policies and regulations associated with the award. Although Principal Investigators may have administrative staff (Grants Office, Administration & Finance, Budget Unit Divisions) to assist them with the management of project funds, the ultimate responsibility for the management of the sponsored research award rests with the Principal Investigator. The PI's fundamental responsibilities during the post-award phase of a sponsored research award include:

- Execute the project as outlined in the funded proposal, using sound management techniques in collaboration with the Grants Office and the Administration & Finance office.
- Carry out the project's financial plan as presented in the funded proposal, or make changes to the plan following a prescribed set of policies and procedures.
- Report project progress to the sponsor as outlined in the terms of the award.
- Maintain an accurate record of project related expenses.
- Comply with all Stockton policies and procedures related to project management and personnel practices.
- Comply with all applicable sponsor rules, regulations and/or terms and conditions of the award
