

## National Endowment for the Humanities Post-Doctoral Fellowships Library Company of Philadelphia (LCP)

**Deadline:** November 1, 2019

**Amount:** Upper \$37,800 - Lower \$16,800

**Abstract:** National Endowment for the Humanities Post Doctoral Fellowships support research in residence at the Library Company on any subject relevant to its collections, which are capable of supporting research in a variety of fields and disciplines relating to the history of America and the Atlantic world from the 17th through the 19th centuries.

**Eligibility:** *Individuals who have completed their formal professional training. Advanced degree candidates must have completed all requirements, except for the actual conferral of the degree, by the application deadline. Foreign nationals are not eligible to apply unless they have lived in the United States for the three years immediately preceding the application deadline.*
