

Fraternity & Sorority life Guidelines for Fall 2020

General Expectations

Following Stockton's Community Agreement, which includes:

- Wearing of face masks
- Maintaining social distance
- Responsibility of cleaning used common spaces
- Reimagining large scale events to follow social distancing guidelines
- Following signage throughout buildings and campus spaces
- Making health and safety of members the priority
- Follow all University, State, and CDC guidelines

FSL Sponsored Events & Programs

- All FSL events and programs should be held virtually whenever possible, however campus space is still reservable for non-meetings, but with updated capacities to meet guidelines.
- Programs and training hosted by the Office of Student Development will be hosted virtually for the duration of Fall 2020.

Guidelines for Chapter Sponsored Activities

Chapters may continue to operate and engage their membership. We encourage your executive boards to work with your advisors and Student Development staff to reimagine certain events and programs (sisterhoods, philanthropy, service, etc.).

- Meetings
 - Due to the pandemic being a fluid situation, all meetings will be held virtually until further notice.
 - Meetings with the Greek Advisor are [by appointment](#) via Zoom only.
 - See updates regarding campus spaces on the [Event Services](#) website.
- Recruitment, Membership Intake, and Membership Education Process
 - Fraternities and Sororities will continue to be permitted to conduct recruitment and membership intake activities as per the [Fraternity & Sorority Life Intake Requirements](#).
 - Recruitment and membership intake activities must be in accordance with University, CDC and State guidance.
 - We recommend that chapters utilize a virtual process to conduct interviews, events, and informational sessions.
- Social Events & Parties
 - **No social events in (indoor/outdoor) private residences will be approved until further notice.** This was decided because there is no way to correctly measure the space capacity. Hosting an event at a private residence that brings large numbers of people together who do not live in the same residence has been shown to be a source of rapid community spread.

- Social events at third-party vendors may still be approved if regulations are followed.
- All events with alcohol present must be approved as per [Fraternity & Sorority Life](#) regulations, and will be evaluated based on health and safety, University, CDC, and State guidance.

General Questions to Ask Yourself:

- Is this event/program critical to the mission and values of my organization?
- Does this meeting/event/program need to be held in-person in order to be successful?
- Does this space hold the capacity for X amount of people to be comfortably seated in a 6-foot minimum distance, to ensure social distancing and limiting the risk of exposure?
- What potential risks of exposure are associated with this event/program? What are ways in which we can mitigate that risk?
- Have I spoke with my advisors and Student Development staff to review our program/event plan?
- What are the potential public relations considerations for hosting such an event?
