Call for Proposals

Provost Faculty Opportunities Fund –

- Support for travel to conferences, student assistant, professional services or supplies related to scholarship in 2020 Initiatives. For event occurring during October 1st – December 30th, 2015.
- An average of \$2,000 per award is available.

R&PD: Course Release –

- Spring semester Course Release. Project MUST fall within January 1st and June 15th, 2016.
- 4 courses are available for award.

Sabbatical –

- Support for a substantial Project that will result in advancing scholarship with tangible outcomes.
- 1 Semester average award.
- [Guidelines](#) are available on the ORSP website and [applications](#) are due no later than 5:00pm, October 15, 2015 for Fiscal Year 17 (7/1/16 – 6/30/17).

Provider Agreement Processing

All grant related service provider agreements between Stockton and individuals/entities paid from grant accounts, should be forwarded to the Office of Research and Sponsored Programs. After review, the ORSP will then forward the agreement to the Office of Legal Counsel, copying the BUDs on the email.

Agreements should be sent to the ORSP using the email address postaward@stockton.edu. Agreements sent directly to the Office of Legal Counsel, bypassing the ORSP, will experience a delay in processing.

Annual Reports for R&PD, CDC, Sabbatical, and Academic Advising Internal Awards are due **October 15, 2015**.

Please complete an [“Annual Report”](#) form for each award you received for FY 2015, and any outstanding reports for prior years.

Completed reports should be e-mailed to the Office of Research and Sponsored Programs, as well as sent to Interim Provost Davenport and your Dean or Supervisor.

All annual reports must be up to date in order to be considered for any additional internal award funding.

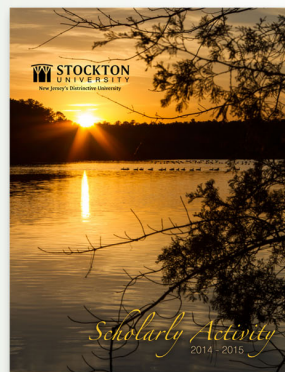
Welcome Back Faculty!
